This is a new major step forward in the construction of Crealis group, whose **main aim is to make our customers' demands a key focus**. The agreement was completed on the 31st of January 2022 and the transaction was finalised on **the 12th of April 2022**.



Following this agreement, harnessing its **15 production sites worldwide with almost 1,800 members of staff, Enoflex is aiming to achieve consolidated sales of around €280 M in 2022 (322M\$).**
